SW MSPDP leagues – The best of the best in dynamic debates – Public Welcome

The Public Debate Program (PDP), centered at Claremont McKenna College and the Claremont Colleges Debate Union, supports debate training for more than 800,000 secondary school teachers and students in 29 countries. One of its long-standing debate outreach initiatives is the Middle School Public Debate Program (MSPDP), among the largest and fastest-growing debate programs in the world.

The Southwest Regional Tournament is one part of the US debate championship for the MSPDP. The regional and national tournaments are an opportunity to celebrate the achievements of all students participating in MSPDP leagues throughout the country. This year, the MSPDP will significantly increase the number of competing teams by sponsoring five US Regional Championships, with a unified national championship at Claremont McKenna College. The 2018 MSPDP National Championship will be the largest single-event debate tournament in the world.

Not every student is able to participate in a regional championship tournament. But every MSPDP student makes an extraordinary effort pursuing sophisticated, professional oral communication skills – public speaking, research, critical listening, argumentation, and refutation. These skills are developed in league invitational tournaments across the country and around the world. Congratulations to all MSPDP debaters and the volunteer teachers, coaches, judges, and families supporting them!

LEAGUE REGISTRATION AND FEES

All important dates/deadlines are underlined.

League president registration begins Friday, March 30. League presidents register qualifying teams from their league. Each president should submit a list of qualifying teams (including school name and first and last names of debaters), as well as certified judges for the registered teams. Contact information is required. A league may not register any teams beyond the number of approved bids. Email the list by Friday, April 6 to John Meany, john.meany@cmc.edu.

SCHOOL REGISTRATION

In addition to the official league registration, schools confirm registration for teams/judges and register for fees and/or meals.

A school should submit its registration and tournament fee (\$50 per team, payable to Claremont McKenna College) to John Meany. Detailed information on registration is included in this invitation.

• ANNUAL MSPDP MEMBERSHIP DUES AND SELECTIVE LEAGUE DUES

A number of leagues and schools have not yet paid annual MSPDP membership fees (\$25 per school) and/or selective league dues. IVDL, RCDL, PCDL/LADL, and GWDL leagues pay leagues dues, in addition to member fees. Leagues and schools must do so prior to the championship. League presidents should inform all schools. Leagues and schools must be current on annual membership and league dues. School confirmation of teams/judges and school registration for fees/meals is done by the school representative/teacher/coach. Opens Friday, March 30 and should be delivered by Wednesday, April 18.

The coach of a school registers the qualifying team(s) from the school and the MSPDP-certified judge for each qualifying team. One certified judge is required for each registered team.

Dining and Meals Registration Fees

No one is required to eat at Mt. San Antonio College. Dining on campus is convenient and will ensure that the tournament can stay on schedule.
